SPECIAL NOTICE ABOUT ELINGS PARK

Elings Park is an independent nonprofit park. Please respect this beautiful site. This trial will be held at an on-leash, reserved area within the park. Dogs participating at this trial must be on-leash except when running in the ring or working the practice jump. A limited number of dogs visiting this 230-acre park hold memberships that allow off-leash privileges at non-reserved lawn areas. If you walk your dog in those areas you may encounter off-leash dogs. Overly aggressive dogs, dogs in heat, and dogs with illnesses are not permitted in Elings Park. Avoid areas that are posted “reserved” for weddings, such as Godric Grove, Singleton Pavilion, and The Bluffs at South Park. These are closed to the public from 7am to dusk in preparation for weddings.

ENTRIES and CLOSING DATES

Entries must be received by 8:00 p.m. Saturday, July 31. Entries will be accepted by Federal Express or Express Mail **only if the Signature Waiver is signed.** No telephone entries will be accepted. There is no limit to the number of dogs that can participate in this agility trial. You may request a change in or cancel your entry by e-mail to vapordog@earthlink.net at any time prior to the closing date. No refundable cancellations will be permitted after the closing date.

Secondary Closing Date: Advancement in level for these entries must be received by Monday, August 9 at 6:00 p.m. Requests must be made by email (vapordog@earthlink.net).

For Exhibition Only entries are not allowed.

CHECK-IN and MEASURING

DO NOT send cards or copies of cards.

All competitors must check in their first day of competition. All dogs must be measured prior to being checked in unless the dog jumps 26" (22"P), the handler presents a permanent card, a temporary card with 3 signatures awaiting a CMJ or check-in letter issued by USDAA or print out from subscriber account indicating the dog is permanently carded.

If a dog measures up, it must jump the higher height and will be placed first in that jump height. The dog may NOT be moved to Performance at check-in if it is measured up. The dog that is measured up must jump at the higher jump height.

Check-in and measuring will begin at 7:30 a.m. Saturday and Sunday mornings. Dogs and handlers who have checked in on Saturday do not need to be checked in on Saturday or Sunday.

Check your confirmation to verify check-in and walk through times.

Any dog and handler not present when their number is called will be ineligible to run, unless prior arrangements are made with the gate steward.

CLASS DESCRIPTIONS

Two certification programs will be offered at this event – Championship and Performance. Competitors may enter both Championship and Performance Program classes for which they are eligible; however, under NO circumstance may a dog be entered in more than one level or program for any given class (i.e. Masters Jumpers may not enter any other level/program of jumpers).

CHAMPIONSHIP PROGRAM

The Starters Standard classes shall be for dogs that have not earned the *Agility Dog*[®] title or a Starters Standard title. Starters Non-standard classes shall be for dogs that have not earned a title in the class being entered (Starters Gamblers, Starters Jumpers, Starters Relay-3 different partners required-or Starters Snooker) or a qualifying score in the equivalent non-standard class at the Advanced or Masters level. Three qualifying scores in the standard class from two different judges along with one qualifying score in each of the nonstandard classes is required to earn the *Agility Dog* title.

The Advanced Standard classes shall be for dogs that have earned the *Agility Dog*[®] title or a Starters Standard title. Advanced non-standard classes shall be for dogs that have earned the *Agility Dog*[®] title or that have earned a title in the equivalent non-standard class at the Starters level, but have not earned the equivalent Advanced non-standard title or a qualifying score in the

equivalent non-standard class at the Masters level. Three qualifying scores in the standard class from two different judges along with one qualifying score in each of the nonstandard classes is required to earn the *Advanced Agility Dog* title.

The Master's Standard classes shall be for dogs that have earned the *Advanced Agility Dog*[®] title or the *Advanced Standard* title. Masters non-standard classes shall be for dogs that have earned the *Advanced Agility Dog*[®] title, the equivalent non-standard title at the Advanced level, or that had previously qualified for entry into the equivalent Masters non-standard class prior to January 1, 2004.

PERFORMANCE PROGRAM

Generally, Level I classes are run on courses used for Starters classes, Level II classes are run on courses used for Advanced classes and Level III classes are run on courses used for Masters classes, with the following exceptions: the A-frame is set at 5'6", jump heights are one height class lower as set forth in Notes to Competitors, no spread hurdles are utilized and time standards in the standard, jumpers classes are extended by 3 seconds beyond that utilized in the Championship Program. Eligibility is determined as follows:

The Performance I classes shall be for any dog that has not earned the *Performance Dog*^{FM} title or a title in the standard AND all of the nonstandard classes. Three qualifying scores in the standard class from two different judges along with one qualifying score in each of the nonstandard classes (i.e., Snooker, Jumpers and Gamblers) is required to earn the *Performance Dog*^{FM} title.

The Performance II classes shall be for any dog that has earned the *Performance Dog*^{FM} title, the *Veteran Agility Dog*SM title, or has received three qualifying scores in a Level I standard or corresponding nonstandard class with scores being earned from two different judges shall be eligible for entry into Level II standard or nonstandard classes without having earned the *Performance Dog*^F title. Three qualifying scores in the standard class from two different judges along with one qualifying score in each of the nonstandard classes is required to earn the *Performance Dog*^{IF} title.

The Performance III level Standard classes shall be for any dog that has earned the *Performance Dog*^{IF} title, the *Performance Standard II* title, the *Advanced Agility Dog*[®] title, or the *Veteran Advanced Agility Dog*SM title. Performance III non-standard classes shall be for dogs having earned the *Performance Dog*^{IF} title, the *Advanced Agility Dog*[®] title, the equivalent non-standard title at the Advanced or Performance II level, or that had previously qualified for entry into the equivalent Performance non-standard class prior to January 1, 2004.

NON-STANDARD CLASS DESCRIPTIONS

These non-standard classes are pursuant to the provisions of Chapters 6 & 7 of USDAA Rules & Regulations.

Gamblers Class: consists of a course with no pre-determined route and each obstacle is assigned a point value. In the 'opening' period the handler seeks to accumulate points by performing the obstacles of his/her choice in the time allotted. At the conclusion of the 'opening' the handler attempts the 'gamble', a sequence designated by the judge to be handled from a distance, for additional points.

Jumpers Class: consists of a course of jumps and may include a tire and tunnels.

Snooker Class: has an 'opening' sequence of point collection similar to the Gamblers followed by a closing sequence of a set pattern. Roughly parallels the billiards game of 'Snooker', requiring the dog to successfully complete a 'red' jump prior to attempting an obstacle designated as any other color.

Pairs Relay: consists of a standard course with one dog and handler running a portion of the course, followed by a baton exchange to a second handler and dog who run the second portion of the course. Dogs must be in the same level and height division; i.e. mini (Ch12/16, Perf 8/12) or open (Ch22/26, Perf 16/22). In the event there is only one entrant in a level in a program, a partner may NOT be chosen at random or from another level or program to make a pair. The unpaired competitor may receive a refund for the class entry. Relay is required for titling in all levels of Performance as of 1/1/09.

AWARDS

Santa Barbara Flyers Dog Sports will award rosettes for 1st through 4th in each class at each jump height. 1st place dogs in each jump height will be awarded a dog toy. Pairs awards will be awarded by mini and open divisions. All dogs earning a qualifying score in a titling class will receive a maroon qualifying ribbon.

NOTICE TO COMPETITORS

Competitors, through submission of entry, acknowledge that they are knowledgeable of USDAA Rules and Regulations, as amended July 1, 2009, including but not limited to the following rules regarding entry, and will comply. USDAA's official Rules and Regulations are hereby incorporated by reference, a copy of which may be viewed online at www.usdaa.com.

This test is open to all dogs being at least eighteen months of age, including purebred and non-purebred, except bitches in season, dogs suffering from any deformity, injury or illness that may affect the dog's ability to perform safely, or dogs exhibiting signs of aggression.

All dogs must be registered with USDAA in order to compete in USDAA sanctioned events. You may register online at www.usdaa.com, General Information, to receive a registration number immediately and a measurement card prior to the show. Registration may also be made concurrently with entry to this show, a form for which is included in this Agility Test Schedule.

No leads, collars, food, toys or other aids or devices shall be permitted on the course at any time. No training, pinch, or shock collars will be permitted on or around the course at any time.

Safety shall be of foremost consideration at all times. Handlers, through entry at this event, accept full responsibility for themselves, their guests and the actions of their dogs. Any competitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show. In such case, no refund of any entry fees will be made.

The Organizing Committee of an event may refuse the entry of any competitor or dog for just cause should the committee view that participation by competitor or dog would be prejudicial to

the sport. However, any committee so doing must notify the competitor in writing (with a copy to the USDAA office) in anticipation of or upon receipt of entry. The notice must include the reason for refusing the entry and a brief explanation of the basis for their decision. The burden of responsibility for appropriateness of such action rests solely with the host group and its Organizing Committee.

No entries shall be accepted, changed, altered or withdrawn after the closing date. THERE SHALL BE NO REFUNDS for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal or for bitches that come in season after the closing date. Returned checks do not constitute a valid entry. There will be a \$20.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler. No refunds for overpayment of fees will be made for less than \$10.00. No entry fees will be refunded if the Test cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.

Dogs must remain on leash at all times, except when competing in the ring or in the warm-up jump area. No dogs may be left unattended except when properly kenneled in designated kennel areas. Day kenneling only is permitted. USDAA and Santa Barbara Flyers Dog Sports cannot and do not assume any liability for loss of any items left unattended.

Agility obstacles shall meet the requirements of USDAA Rules and Regulations. Competitors (handler or their dog) may not enter any class held for title under a judge who resides in the same household or with whom they have trained in the past ten (10) days. Dogs must be exercised only in designated areas. **Please pick up after your dog. Fault limits may be applied** in all classes for which faults are assessed. Limits shall be announced during the judges' briefings. Mismatches or incomplete pairs shall be accepted as draw entries only. There will be no equipment familiarization at this event.

All Competitors, through entry at this event, waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast and telecast rights for this event are the exclusive property of United States Dog Agility Association, Inc.

Portions of this event may be taped for television. Through entry at this event, ALL COMPETITORS and HANDLERS HEREBY GRANT to USDAA and its representatives, agents, and assigns, all rights and permission to use or appropriate his/her and their dog's name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cablecast, transmission or distribution in any format or media now known or hereafter to become known. All exhibitors and handlers hereby release USDAA and its representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of publicity, right of personality, or any similar right.
